## RULES AND REGULATIONS

The Sarge & Sons Demolition Derby is promoted as an unusual spectator attraction. **In the interest of safety.** Drivers and Mechanics are subject to, and must obey the following rules and regulations which are set up by the promoter and the track where this event is being held: The rules and/or regulations set forth herein are designed to provide for the orderly conduct of racing events and to establish minimum acceptable requirements for such events. These rules shall govern the condition of all events, and by participating in these events, all participants are deemed to have complied with these rules. **NO EXPRESSED OR IMPLIED WARRANTY OF SAFETY SHALL RESULT FROM PUBLICATIONS OF OR COMPLIANCE WITH THESE RULES AND OR REGULATIONS.** They are intended as a guide for the conduct of the sport and are in no way a guarantee against injury or death to a participant, spectator, or official.

The race director shall be empowered to permit reasonable and appropriate deviation from any of the specifications herein or impose any further restrictions that in his/her opinion does not alter the minimum acceptable requirements. **NO EXPRESSED OR IMPLIED WARRANTY OF SAFETY SHALL RESULT FROM SUCH ALTERATION OF SPECIFICATIONS.** Any interpretation or deviation of these rules is left to the discretion of the officials. Their decision is final.

- A. Each driver must fill out an entry blank. All drivers must supply their own cars, **only one entry per person per class.** Proof of ownership may be required on each car entered.
- B. **All drivers and/or pit persons 16 or 17 years of age must have a notarized release signed by his or her parent or legal guardian. Nobody under 16 years of age can drive or be in the pit area.**
- C. **The track or promoter reserves the right to approve or reject any, and all entries.**
- D. All persons must sign the release sheet and receive a pit pass to be permitted in the pit area or on the track. **Drivers only to receive free pit pass** upon registration of a car on day of the show. **All other pit passes are \$20.00.**
- E. No drinking of alcoholic beverages on track, emergency vehicle area or in the pit area at any time. Any driver or pit person under the influence of alcohol or drugs will be immediately disqualified and removed from the grounds.
- F. **No one riding outside of cars anytime due to insurance regulations.**
- G. **Any driver or crew member disobeying the rules will cause his or her car to be disqualified.** Unsportsmanlike conduct will not be tolerated and will be grounds for disqualification and barring from future derbies. Drivers are responsible for the actions of their crew members.
- H. Contestants of the Sarge & Sons Demolition Derby are not employees of Sarge & Sons Demolition Derby. Sarge & Sons Demolition Derby will not be responsible for any damage caused by driver's negligence on the track or in the pit area. "Drivers and pit personnel are responsible for any damage caused by their negligence on the track or in the pit area."
- I. The promoter, track owner or fair association will not be held responsible for any cars, parts/equipment or personal property before, during and after the show or overnight.
- J. **Car and driver must sign in at registration desk at least one hour prior to show time or a \$10.00 fine will be imposed for late arrivals.**

## TOWING AND TRANSPORTING CARS

Towing and transporting Demolition Derby cars to and from race locations must meet highway safety codes (including proper light controls, safety chains, tow bars, towing trailers, etc.)

## RUNNING

**“FIGURE 8” RACING RULES ARE THE SAME AS DEMOLITION DERBY RULES WITH THE FOLLOWING EXCEPTIONS**

1. **Safety belt, D.O.T. approved helmet, goggles, safety glasses or face shields are required. Long pants and shirts or jackets are required.**
2. **No deliberate head-on collisions and no deliberate hitting on the driver's door.**
3. **Vehicles must have dependable brakes at all times and boundaries must be observed.**
4. **A vehicle will be disqualified if ANY door comes open during the heat.**

5. Driver's door must be securely fastened. A bar, steel c-channel, large lawn mower blade or guardrail must be attached to or in the door. Reinforcement must not extend out from door more than 3". REINFORCEMENT IS MANDATORY!!
  6. Gas tanks may remain in original position, if located in front of the rear axle.
  7. Starting position will be determined upon arrival.
  8. The winner is determined by the first car to cross the finish line after a predetermined number of laps.
  9. Vehicles must remain in a forward motion **EXCEPT**, when a bottle neck occurs at a corner. Reverse will be allowed. Deliberate contact while in reverse will result in a disqualification at the discretion of the officials.
  10. The following will result in disqualification; gas leak, fire, immobilized on track or barrier, leaving the track area, reckless driving or intentionally leaving the "Figure 8" pattern, so as to intentionally hit another driver.
- Decision of the official is final.**

All cars are to be removed from fairgrounds or race track following the show or they will become the property of Sarge & Sons Demolition Derby and the officials will have them removed (unless otherwise specified at the driver's meeting). A removal deposit may be required in some areas. (Additional safety regulations may be imposed, depending on track.)  
Decision of the official is final.

These rules supersede any, and all rules previously used.
